Economic & Workforce Development	1.2	Continue to work on the buildout of the Career Center to be located at 50 Shelby (Passage development) which will serve those with barriers to employment. Continue to work with Exodus Refugee and connect their clients with jobs in the neighborhood
	2.3	Continue to work with Uplift Produce to expand and hone their current business and as they look to expand and double their production capacity on the PR Mallory Campus
	3.2	Working on the planning process for the Black Mountain site and development projects for Sherman Park
Education	3.2, 3.3, 3.4	3.2 — working to bring Elevate Indianapolis to serve Purdue Polytechnic students in a building across the street 3.3 - Englewood CDC was funded by IHCDA to develop Englewood Homes which will be 40 units in 20 duplexes on vacant lots in the Englewood neighborhood. Homes will be available to low-income families and marketed towards families of Purdue Polytechnic HS, Paramount Englewood and DayStar Childcare. 3.4 - Paramount Englewood has a Community Health network service provider located at the Mallory building who is able to help students specifically with mental health issues as well as social-emotional well-being and overall health and wellness.
Health, Wellness & Family Strengthening	3.1	ECDC provides services around homelessness prevention and eviction prevention to current residents - in 2021, ECDC forgave back-balances of residents as part of a "jubilee" effort to ensure they would not be evicted.  Additionally, ECDC is in the process of doubling our housing offerings by adding 5 developments of about 160 units - all but one of these developments has a component of permanent supportive housing to help more individuals and families achieve housing stability and homelessness prevention.
	4.7	ECDC continues to operate the Near Eastside Soccer Alliance which serves about 200 kids each season with low-cost, accessible and safe recreational opportunities for kids and families. ECDC was just awarded \$2,500 from MIBOR for operating support and scholarships for families.
Housing	1.6	ECDC is working on a Temple Avenue development between Washington and New York Streets that would include more dense homeownership opportunities
	2.3	Working on 4 PSH developments currently
	3.3	Continue to offer our supports and input into the CLT development

### **Westminster Neighborhood Services**

	Action Items Addressed	Method(s) of Addressing Action Items
Education	5.2, 5.3, 5.4, 5.6	Westminster's youth program provides quality out-of-school time for children on the Near Eastside. Westminster has a licensed mental health specialist working with our kids on social and emotional skills, we feed our kids dinner every night to ensure they have a well-balanced meal, and they have outdoor play time daily weather permitting. Our goal is to meet the needs of the kids and provide access to services that are needed most.
Equity & Engagement	2.1, 2.2	Began creating a list of grassroots resources and equitable meeting spaces. Began an outreach strategy that can be applied to all Near Eastside organizations.
	3.2	Began conversations with Martin University, who offers several implicit bias and DEI trainings.
Health, Wellness & Family Strengthening	1.5	Began the process of getting certified in trauma informed care so that trainings can be facilitated at a later date.
	2.4	Trying to make contact with NE Games. We made contact in 2020, but (for obvious reasons) we were unable to organize the walking event that year.
	3.3	Working with the Domestic Violence Network to provide resources and to apply funding to new resources.
	5.10, 5.11	Community Food Boxes: Boxes were started in the first quarter of 2021. We have begun working with Midwest Associations to finish them and begin installation this summer. Community Meals: We are a food pantry. Westminster continues to have soup kitchen meals twice a week, partners with Thy Kingdom Crumb for a free food truck meal, and Circle City Dinner Church does weekly dinner.
	6.4	The health assessment has been created and we've been assessing our neighbors for months. At our Health Fair in May, we will begin distributing the assessment officially. Then we will contact QoL partners to begin assessing their neighbors as well.

#### **Shepherd Community Center**

	Action Items Addressed	Method(s) of Addressing Action Items
Economic & Workforce Development	1.1, 1.2, 1.3, 1.4, 1.5	We continue to operate our CWF site and make connections for them to employment, training, and certifications.  Also, we made a connection to a lending opportunity that would give an option to neighbors instead of predatory lending. It's called the Halo app and promotes peer to peer lending. We are exploring how to implement this in our community.
Education	2.1, 2.4, 2.5	We continue to offer our K-5th grade school as an option for families and also make connections to other schools in the neighborhood. We also enhanced our professional development by adding a social emotional learning component that focused on trauma informed care. Our programs also focus on at-risk children and youth and particularly those in our neighborhood.
	3.1, 3.2, 3.4	We continue to train teachers and OST staff on social-emotional learning and we also added professional development from Purdue NW regarding academic learning strategies and learning recovery. We also continue to engage families and one of the key ways we did that was through a literacy family event that had over 40 families participate.
	4.1, 4.2, 4.3, 4.4	We continue to promote 21st century and we also use our in-school and out-of-school time programs to promote higher ed through a growth mindset approach. Our summer programs specifically focus on college prep and employment prep.
	5.1, 5.2, 5.3, 5.4, 5.6	We continue to offer OST program for elem, middle and high school youth. We have offered additional professional development this quarter for our OST staff as well and we also implement social emotional learning in our OST programs. We also had a Doctoral student for Occupational Therapy pilot a peer mentoring program.
	6.2	We worked with the Mindtrust on a grant to recruit new teachers to the neighborhood.
Safety	1.4, 1.7	We continue to promote our Shalom project with an IMPD officer and paramedic serving our neighborhood each day and engaging with youth and adults alike, both in the neigborhood and on-site at Shepherd.
	2.3, 2.6	Our IMPD officer coordinates with our social work team at Shepherd and also multiple hospital social workers. Also we continue to work with Boner on the BCJI grant and the opportunity to connect neighbors who are involved in the justice system with our CWF's.
